# COVID-19 Ushered in Telehealth



## Telehealth Impact Survey COVID-19 Healthcare Coalition Telehealth Workgroup

American Medical Association, American Telemedicine Association, Change Healthcare, Digital Medicine Society, Massachusetts Health Quality Partners, MassChallenge HealthTech, Mayo Clinic, and MITRE.



**Systems and practices** across the country selected a vendor, trained thousands of providers, and created new tasks/workflows in a **matter of days**.

**60%** reported that telehealth has improved the health of their patients.

**68%** are motivated to increase the use of telehealth in their practice.

**55%** reported it improved satisfaction in their work

**73.3%** indicated that no or low reimbursement will be a major challenge post-COVID

**More than 64%** said technology challenges for patients were a barrier to the sustainable use of telehealth.

**58%** are not able to currently access their telehealth technology directly from their electronic health records

# AMA Return on Health Research

---

Understand how various types of physicians, practices and health systems are currently experiencing and quantifying the value of virtual care.

---

Develop a ‘return on health’ conceptual framework for measuring the value of virtual care that describes each of the potential value streams it can unlock.

---

Identify key metrics for measuring the value that virtual care can deliver across defined each value stream (e.g. clinical quality and outcomes, operational improvements, financial improvements, access to care, patient/physician experiences, health equity).

---

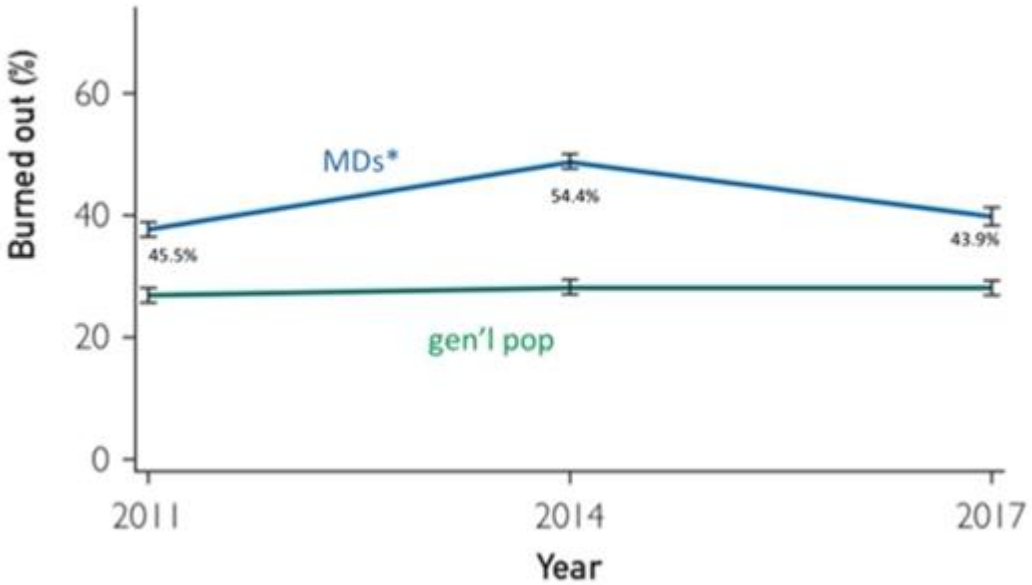
Develop 10 illustrative use cases that portray how different virtual care modalities deliver value in a range set of healthcare environments (e.g. fee-for-service vs. value-based payment; small health system vs. large medical group, etc.).

---

Develop and issue a report that uses the illustrative case studies to bring depth and practical examples to the conceptual framework and provides industry with an actionable framework for defining and measuring the value of virtual care.

# Interoperability – Secure Exchange

# Availability of Personal Protective Equipment (Policy H440.810, I-20)

Whereas, Physicians have an ethical duty to serve during pandemics.....

- 1. Our AMA affirms that the medical staff of each health care institution should be integrally involved in disaster planning, strategy and tactical management of ongoing crises.**
2. Our AMA supports evidence-based standards and national guidelines for PPE use, reuse, and appropriate cleaning/decontamination during surge conditions.
3. Our AMA will AMA advocate that it is the responsibility of health care facilities to provide sufficient personal protective equipment (PPE) for all employees and staff in the event of a pandemic, natural disaster, or other surge in patient volume or PPE need.
- 4. Our AMA supports physicians and health care professionals in being permitted to use their professional judgement and augment institution-provided PPE with additional, appropriately decontaminated, personally-provided personal protective equipment (PPE) without penalty.**
- 5. Our AMA supports a physician's right to participate in public commentary addressing the adequacy of clinical resources and/or health and environmental safety conditions necessary to provide appropriate and safe care of patients and physicians during a pandemic or natural disaster.**
6. Our AMA will work with the HHS Office of the Assistant Secretary for Preparedness and Response to gain an understanding of the PPE supply chain and ensure the adequacy of the Strategic National Stockpile for public health emergencies.

# Other OMSS Policy Activity

## Assessing Competency in Late Career Physicians

- Policy D-275.956, “Assuring safe and effective care for patients by late career physicians” – identify and convene
- Work group noted that very few hospitals have age specific guidelines and that there is evidence that the number of disciplinary actions increases at 65 and 70
- Status: Awaiting a report from the Council on Medical Education which is expected to include a set of guiding principles as a basis for developing guidelines for the screening and assessment of late career physicians.

## Assistant Physicians

- Assistant Physicians have completed medical school but have not matched with a residency program
- Initiating policy work on whether and how Assistant Physicians should be incorporated into the medical staff oversight process
